Community guide for compliance and reporting

Trash Violations



- Trash is not permitted anywhere in the City of Evans except within appropriate disposal containers.
- Trash refers to any material rejected or discarded, including but not limited to garbage, food waste, animal feces, paper, cans, bottles, glass, containers, rags, cloth or other materials.
- Bagged trash must be disposed of in a timely manner, and shall not be stored for future removal.

Junk or Outdoor Storage Violations

- Junk is not permitted to accumulate on any property within the City of Evans
- Junk refers to items that are outdoors and that are broken, discarded or not reasonably useable, including but not limited to boxes, crates, salvage materials, discarded fence posts, tires, motor vehicle bodies or parts, scrap metal, bedsprings, discarded furniture and all other household goods or appliances, used lumber and other similar objects.
- Outdoor storage is not permitted in residential neighborhoods.
- Prohibited types of outdoor storage include, but are not limited too, construction materials, tires, household appliances, pickup campers, truck bed covers, upholstered furniture that is designed, manufactured, and intended primarily for indoor use.
- Tires, new or old, can breed mosquitoes and must be stored indoors.

Penalties for Violation

The City of Evans seeks to attain voluntary compliance with the municipal code through the administration of a Notice of Violation. When voluntary compliance is not attained, penalties are assessed as follows:

First Violation - \$150
Second Violation - \$500
Third Violation - \$999
Subsequent Violations - \$999
